

## Lasqueti Internet Access Society AGM - May 26th 2015 - Minutes

**Review of the year**; Richard C. Upgrading to E- 30 completed. Trying to maintain our present rates without increases means we need more volunteers as our Telus rate has substantially increased. Bill paying has been streamlined this year. The contract with Gillies Bay is completed so we no longer receive \$1000 per month from them. We must get the office at JFC completed by June 15<sup>th</sup> as the portable unit has been sold and we have to move out. A tower also needs to be erected at the JFC site. It has been purchased but has not arrived on island yet.

**Financial report;** Willy reported how the general financial report was changing to use 1/3 of our income for Telus, 1/3 for labour, and 1/3 for materials and upgrades. Questions and discussions ensued around hotspots, paypal fees and our bylaw restrictions that affect banking practices. Currently LIAS has 118 year round members. **Work Plans**; Complete office and put up new tower at JFC. Install new tower at Guys. Upgrade all access points with Laurence's AP being the first one.

**Volunteer Organization**; Young energy needed to get heavy things carried up hills. Richard B. to explore installing a guy wire at Laurence's to assist in getting materials up the rocks into position.
